<u>PAID HOLIDAY – SATURDAY, JULY 28TH – HARRY BRIDGES BIRTHDAY</u> – Is an automatic holiday for those members who worked 1300 hours (1200 if over 60) or more in 2006. For those who did not meet the automatic holiday hours requirement, you must be available for work at least two of the five days, Monday thru Friday, July 30th – August 3rd. Only those members who worked at least 800 hours (700 if over age 60) in 2006 are entitled to receive or file claims for paid holidays.

PORT HOURS – The Union has not met with the Employer over the Port Hours Formula since the report given at the July membership meeting. Therefore and until further notice, the formula used for the month of July will remain in effect for the month of August.

MEMORIAL SERVICE FOR GEORGE KUVAKAS SR. – The Southern California Pensioners Group has notified us that they will be conducting a memorial service for George Kuvakas Sr., who passed away on July 9, 2007. The service will be held at the ILWU Local 13 Memorial Hall on Wednesday, August 1, 2007 at 11 a.m.

REMINDER FROM AREA BENEFITS DIRECTOR RON COSTA — When getting referrals from your PPO doctor, you should get 3 referrals. Make sure who you are being referred to is a PPO provider. This does not always happen. When you are referred to a non-PPO provider, you will have out of pocket expenses which can sometimes be substantial. Please make sure you are being referred to a PPO doctor and a PPO facility, whether out-patient or in-patient (hospital). If you are in doubt, contact the Coastwise Claims office at 800-955-7376.

SUPPORT FOR LOCAL 6 WORKERS AT WASTE MANAGEMENT – Over 300 members of ILWU Local 6 employed by Waste Management are engaged in a courageous struggle supporting their Brothers and Sisters of Teamsters Local 70 who are locked out by the employer. Our Local 6 members are refusing to cross the Local 70 picket line and they have been out for over 3 weeks. Our Local 6 Brothers and Sisters are making a significant financial sacrifice and they need our help.
