**Accident Analysis** 

#### **Serious Accidents**

- 1. A committee member informed the group about C/O that knocked off a stack of containers while discharging. The C/O hit a 6 high stack in the "C" cells, the containers rolled into the A and B cell and ended up knocking off a total of 5 containers off the vessel on to the deck. A dock signal twisted her ankle fleeing from the falling cans. The C/O was shaken up and containers ended up falling all the way into lane 3.
- 2. An employer spoke about an incident at pier F. While working steel, tires and coil they were removing a 15 on lift from the hatch, an individual was injured by being pinched between the mast and the cage. The machine was left running after the cargo was discharged to the dock. The paramedics were called and the individual was taken to the hospital. His injuries included a collapsed lung and 3 broken ribs. He was pinched in between the boom and the mast of the cage. The heavylift was a Taylor, 15 ton #3303

# 1. Tophandler Sub-Committee

The tophandler sub-committee is looking to get information on tophandler versus pick-up truck accidents. They would like the companies to submit incident information. They want to look at incidents that have happened in the last 2 years.
