NOMINATIONS OPEN APRIL 2nd – MAY 1st – All nomination forms must be submitted by 5:00 p.m. the cut-off day, Tuesday, May 1st, for the following offices: Secretary/BA, Day Business Agent/Patrolman, Dispatcher (4), Board of Trustees (3) six-month term, Grievance Committee (16) six-month term, Memorial Association (7), Promotions Committee (6) six-month term.

<u>PAID HOLIDAY – MONDAY, MAY 28, 2018 – MEMORIAL DAY</u> – Is an automatic holiday for those members who worked at least 1300 hours (1200 hours if age 60 or over) in 2017. Those members who worked at least 800 hours (700 hours if age 60 or over) but less than 1300 must work two (2) of the four (4) days that week exclusive of the holiday: Tuesday, Wednesday, Thursday, or Friday – May 29th, May 30st, May 31st, or June 1st, to qualify for the paid holiday, or if out on disability during that week, they must request that the Business office file a holiday claim on their behalf with the appropriate medical documentation covering them for that week. *Remember, only members who worked at least 800 hours (700 if age 60 or over) are entitled to file a holiday claim or receive holiday pay.*

The ILWU/Propeller Club Memorial Scholarship Fund was established to honor the memory of longshore workers who have lost their lives working on the waterfront and to assist local high school seniors entering college.

<u>ILWU COAST PRO RATA INCREASE</u> – The ILWU Coast Committee recently notified all Longshore Division Locals of a proposed increase to the Coast Pro Rata. Earlier this year, the Coast Budget Committee met and made a recommendation to raise the Coast Pro Rata for Union Members by \$20.00, which means it would go from its current rate of \$41 per month to \$61 per month. This increase is subject to the review and approval of the delegates at the upcoming June 2018 Coast Longshore Division Caucus in Portland, Oregon. This is a significant increase and if passed, most likely cannot be absorbed through our current dues amount. The Local 63 Board of Trustees will be reviewing this proposed increase and then make their recommendations to the Executive Board and then this issue will be discussed at the June Membership Meeting per the Local 63 Constitution.

FIRST BLOOD MEMORIAL PROGRAM – The ILWU Southern California Pensioners will be holding their annual memorial to those brothers and sisters who were killed on the job throughout the years. Please plan on attending and joining the ILWU family to remember those we have lost. The event will take place on Tuesday, May 15th at 12:00 noon at the base of 6th Street and Harbor Blvd. in San Pedro.

<u>VACATION CLAIMS</u> – Members who did not work the required number of hours to qualify for all or part of their vacation payment due to disability status in 2017 must contact the Business office to request a claim be submitted on their behalf. May 18th, 2018, is the final deadline for an approved claim payment on June 8th, 2018. Any questions regarding a denial of this claim must be directed to Betty Pleas at PMA's Long Beach office.

WELFARE CLAIMS – Members who did not work the required number of hours to qualify for Welfare Plan benefits to continue beyond June 30, 2018, will receive written notification from the ILWU/PMA Benefit Plans that a welfare claim must be submitted. The Local will not automatically submit a claim for you. You <u>must</u> call or come into the Business Office to request a claim be submitted. It is your responsibility to provide the necessary information and request that a Welfare Claim be processed on your behalf. To ensure that you do not lose coverage on July 1, 2018, the ILWU/PMA Benefit Plans office must receive your completed claim no later than May 31, 2018.
