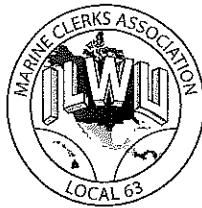

NOMINATIONS OPEN – OCTOBER 1st - NOVEMBER 1st – As per the Constitution, nominations shall open at 8:00 a.m. on Monday, October 1st and close at 5:00 p.m. on Thursday, November 1st for the following offices: President/BA; Vice President/BA; Night Business Agent; Dispatcher (4); Sgt-at-Arms; Labor Relations Committeeperson; Grievance Committee (20); Executive Board (11); Board of Trustees (3); Promotions Committee (6); and Caucus/Convention Delegates (10), Memorial Association (4) – 6 month term.

NOMINATION PROCEDURES: A member filing for office or committee must have dues paid up to the current month, owe no more than \$100 in fines and show continuous membership 18 months or longer in the Local. Any member desiring to be a candidate for any office/committee in the Local shall secure from the Business Office staff a printed form to be properly filled out designating the position to which he/she aspires and contain the signatures of ten members **in good standing (owe no more than \$100 in fines)**. To be eligible to run for any office or committee, the candidate must attend six (6) membership meetings within the year preceding the regular election period for the November ballot. The Business Office staff will fill out the top portion to designate the office the member wishes to seek to run for at the time the form is issued. A nomination form circulated and signed before the office is designated is not valid. Members who obtain signatures on blank nomination forms or who change the office sought for after the signatures have been obtained will be disqualified from running. The Business Office staff will issue each potential candidate a separate nomination form for each office the member is considering running for. A member who is unsure of which office he/she plans to run for should complete a separate form for each potential office. However, under Article IV, Section (F) of the Local 63 Constitution, members may only file for one (1) office excluding the office of Caucus/Convention Delegate. Furthermore, members filing for the office of President/BA or Vice President/BA may also file for Executive Board.

INTERNATIONAL ELECTION RESULTS – On September 6, 2018, the ballots for the International Election were counted and were finally completed in the early hours of the next day. On September 10, 2018, the Balloting Committee issued its report with the following information. A total of 44,572 ballots were mailed out to ILWU members and 10,045 ballots were received at the Post Office on the day they were due. There were 1,080 ballots in a box from Panama that were challenged at the outset of the count. During the tabulation, the Balloting Committee challenged the box of ballots from Panama as challenged ballots. The box from Panama was set aside as the tabulation of the U.S. and Canada ballots continued to determine whether the challenge of the Panama ballots would need to be resolved. As the 1,080 ballots from Panama were challenged, the Committee then had to determine whether the number of challenged ballots would make a difference in any races. The Balloting Committee then obtained from Global Election Services (GES), tentative results, a tabulation of all the ballots from the U.S. and Canada. The tentative margin of victory for the offices of International President and International Secretary-Treasurer were less than the number of challenged ballots. Therefore, the Balloting Committee had to make a determination as to whether the ballots from Panama would be counted. At this point, the Balloting Committee ruled that the Panama ballots shall not be counted. Based on the tabulation of ballots from the U.S. and Canada, the Balloting Committee stated the following individuals were elected – President, Willie Adams, Vice President Mainland, Bobby Olvera, Jr., Vice President Hawaii, Wesley Furtado, and Secretary-Treasurer, Ed Ferris. The deadline for filing challenges has now passed and there was a total of 8 challenges filed. On October 1st at 1 p.m. there will be an informal hearing on these challenges at the ILWU Headquarters: 1188 Franklin Street, San Francisco, CA 94109. As more information becomes available we will notify the membership.

AGE 60 AND OVER MEETING EXEMPTION RULE REMINDER – As per the Local 63 Constitution, in order to be exempt from being fined for non-attendance of monthly membership meetings, a member must be age 60 or over, have achieved 5-years in Local 63 and request to sign the required form in the Business Office; any missed meetings after the signing of the form will not be fined. **Please note, that this only exempts a member from being fined, it does not affect the required availability for check-in rule(s).*
