<u>NOMINATIONS OPEN – OCTOBER 1st – NOVEMBER 1st –</u> As per the Constitution, nominations shall open at 8:00 a.m. on Tuesday, October 1st and close at 5:00 p.m. on Friday, November 1st for the following offices: President/BA; Vice President/BA; Night Business Agent; Dispatcher (4); Sgt-at-Arms; Labor Relations Committeeperson; Grievance Committee (20); Executive Board (11); Board of Trustees (3); Promotions Committee (6); and Caucus/Convention Delegates (10), Memorial Association (4) – 6 month term.

NOMINATION PROCEDURES: A member filing for office or committee must have dues paid up to the current month, owe no more than \$100 in fines and show continuous membership 18 months or longer in the Local. Any member desiring to be a candidate for any office/committee in the Local shall secure from the Business Office staff a printed form to be properly filled out designating the position to which he/she aspires and contain the signatures of ten members in good standing (owe no more than \$100 in fines). To be eligible to run for any office or committee, the candidate must have attended six (6) membership meetings within the year preceding the regular election period for the November ballot. The Business Office Staff will fill out the top portion to designate the office the member wishes to run for at the time the form is issued. A nomination form circulated and signed before the office is designated is not valid. Members who obtain signatures on blank nomination forms or who change the office sought for after the signatures have been obtained will be disqualified from running. The Business Office Staff will issue each potential candidate a separate nomination form for each office the member is considering running for. A member who is unsure of which office he/she plans to run for should complete a separate form for each potential office. However, under Article IV, Section (F) of the Local 63 Constitution, members may only file for one (1) office excluding the office of Caucus/Convention Delegate. Furthermore, members filing for the office of President/BA or Vice President/BA may also file for Executive Board.

<u>AGE 60 AND OVER MEETING EXEMPTION RULE REMINDER</u> — As per the Local 63 Constitution, in order to be exempt from being fined for non-attendance of monthly membership meetings, a member must be age 60 or over, have achieved 5-years in Local 63 and request to sign the required form in the Business Office; any missed meetings after the signing of the form will not be fined. *Please note, that this only exempts a member from being fined, it does not affect the required availability for check-in rule(s).

<u>PROMOTIONS COMMITTEE MEETINGS</u> – Please note that the Promotions Committee meets on a monthly basis only and is a monthly volunteered committee. BENEFICIARY DESIGNATION — As a reminder, it is a good idea to update your Life Insurance beneficiary. Benefit Plans will *not* provide the name of your beneficiary to you if you call them, they will advise you to complete a new form and submit it to them. So, if you don't remember who you listed, or need to make any changes, you can pick up the form in the business office or print the form from our website under Resources/ILWU-PMA Benefit Plans/Forms/General Forms/Beneficiary Designation Form. Once completed, mail directly to Benefit Plans to address listed on the form — Local 63 does not keep these on file.

NO DOUBLE-BACK LIST – This list will be generated the first week of the month and posted in the Dispatch Hall and given to Dispatchers. Any member owing any amount of fines/dues at that time will appear on the *No Double-Back List*. If you are on this list and wish to Double Back, pay your outstanding balance in the business office and ask the staff member to indicate on your receipt that you are "Ok to Double Back."
