Members who do not provide PMA with written medical documentation or request an official Leave of Absence approved through the JPLRC for their time away from the industry may risk possible deregistration. PAID HOLIDAYS – SATURDAY, DECEMBER 24 - CHRISTMAS EVE SUNDAY, DECEMBER 25 - CHRISTMAS DAY (DEAD DAY)

To be eligible for Christmas Eve and Christmas Day holiday pay members must be available for work at least two (2) of the four (4) days, Tuesday through Friday, December $27^{th} - 30^{th}$. Members working on Monday, December 26^{th} will be paid at the overtime rate but will NOT count towards the holiday availability date(s) for the holiday pay. Members who are on vacation must notify the Records Clerk no later than December 30^{th} for Christmas Eve and Christmas Day holiday pay.

SATURDAY, DECEMBER 31ST – NEW YEAR'S EVE SUNDAY, JANUARY 1ST – NEW YEAR'S DAY (DEAD DAY)

To be eligible for New Year's Eve and New Year's Day holiday pay members must be available for work at least two (2) of the four (4) days, Tuesday through Friday, January 3rd – 6th. Members working on Monday, January 2nd will be paid at the overtime rate but will NOT count towards the holiday availability date(s) for New Year's Eve and New Year's Day holiday pay. Members who are on vacation must notify the Records Clerk no later than January 6th for holiday pay Members who are on disability for any or all of the two (2) sets of holidays, must submit medical documentation to the Business Office covering the appropriate time. To be eligible to be paid or file a claim for any holidays, members must have worked at least 800 hours (700 if age 60 or over) in 2015.

PAID HOLIDAY – MONDAY, JANUARY 16, 2017 – MARTIN LUTHER KING JR. BIRTHDAY – Is an automatic holiday for those members who worked at least 1300 hours (1200 if age 60 or over) in 2016. Those members who did not, must work at least two (2) of the four (4) days exclusive of the holiday, Tuesday, Wednesday, Thursday or Friday, January 17, 18, 19 or 20. Members who are on disability during the holiday week and worked at least 800 hours (700 if age 60 or over) in 2016 but less than 1300 hours (1200 if age 60 or over) in 2016 must submit a doctor's excuse to the Business Office covering them for the holiday week and request that a claim be submitted on their behalf. Only those members who worked at least 800 hours in 2016 (700 if age 60 or over) are entitled to receive or file for paid holidays in 2017.
