<u>PAID HOLIDAY, SATURDAY, JULY 4TH – INDEPENDENCE DAY</u> – Is a normal work day, and an automatic holiday for those members who worked at least 1300 hours (1200 if age 60 or over) in 2014. For those members who did not meet the automatic holiday requirements, they must be available for work at least two (2) of the four (4) days exclusive of the holiday (Tuesday, Wednesday, Thursday, or Friday, July 7th, 8th, 9th, or 10th. If a member worked less than 1300 hours but at least 800 hours (700 if age 60 or over) in 2014 and is on disability during the holiday week, he/she must request the Business Office to file a claim on their behalf or if on vacation during the holiday week, notify the Records Clerk. Reminder – only those members who WORKED at least 800 hours (700 if age 60 or over) in 2014 are entitled to receive or file for paid holidays in 2015. As the holiday occurs on a weekend, Monday, July 6th will be paid at the over-time rate only for those who work on that day.

NO WORK HOLIDAY, SUNDAY, JULY 5TH – BLOODY THURSDAY – Is a Dead Day. As was agreed-to in past negotiations, Bloody Thursday is a no work holiday, but is NOT a paid holiday. No work shall be performed between 8:00 a.m. July 5th and 8:00 a.m. July 6th, except for military cargo, passenger vessels, and on-dock rail.

NEW PROVISIONS OF THE MOU — The Officers have been meeting with PMA in an effort to implement the new provisions of the MOU, specifically the new 30% occ codes for yard and rail planning, the inverse seniority provision and the update to the Vessel Planners Signatory page to include all companies that employ vessel planners. In regards to the new occ codes, code 122 has been assigned to rail planning and code 123 to yard planning. As of the date of ratification, all Clerks performing yard and rail planning should be payrolled at these new occ codes and all yard and rail planning will now be paid at the 30% rate. For the inverse seniority the JPLRC has been discussing different issues that may arise at each terminal but are working towards a draft list for each terminal. For the vessel planning, the companies that are not signatory to the supplement have been identified and the JPLRC is working on an addendum that will include these employers.

MOU RATIFICATION – The Tentative Agreement reached with PMA was recently ratified and all members should have received their retro check on Friday, June 19th. Members up and down the coast voted by 82 % to approve the new 5-year pact that will expire in 2019. The vote totals were 7,673 "YES" and 1699 "NO." Voting results were certified on May 22nd by the Coast Balloting Committee which is chosen by Coast Longshore Caucus Delegates.

REGISTRATION & NEW TRANSFERS – In last month's bulletin it was reported that the Coast had approved the 150 transfers from Local 13 to Local 63. We did not know at the time, but this was held up pending agreement with all Locals up and down the Coast for registration and transfers. On June 23, 2015 we officially received notification from the Coast Labor Relations Committee that this has been approved. Applications for transfer to Clerks will be made available for a period of 30-calander days beginning Thursday, July 9th through Friday, August 7th, 2015. Applications will be available at the Local 13 Records Office through Ray Pearson. The rate will remain at 30 per month for 5 months and we can expect our first group sometime in August. In addition, the CLRC agreed to the limited (Class B) registration into Local 13 of 600 Port of LA/LB identified Casuals.

<u>ILWU-LOCAL 63 2015 FAMILY SCHOLARSHIP FUND</u> — Is created, organized and funded by ILWU fellow brothers and sisters. Sons and daughters of Local 63 members who are in the 12th grade or current college students are eligible to apply for a monetary award to be used for tuition or books. Please stop by the Local 63 Business Office to pick-up an application with instructions, for a 30-day period beginning Thursday, July 2nd through Friday, July 31st. *The Local will appoint (2) Two members off the floor on the July 2nd Membership Meeting to serve on this Committee.

<u>CWOG</u> – We had a very large number of CWOG claims that were filed on February 16th, 2015 which was a holiday that fell on a Monday and that PMA had failed to pay. We have been working to resolve this at the JPLRC and everyone who had filed a claim on that date should now have been paid if they were checked in and available and did not receive a work opportunity. Please check your pay stub to verify if you received payment. There are a number of other dates that we are working on, primarily on the night side, which we hope to have resolved very soon.
