NOMINATIONS OPEN – OCTOBER 1st – NOVEMBER 1st – As per the Constitution, nominations shall open at 8:00 a.m. on Tuesday, October 1st and close at 5:00 p.m. on Friday, November 1st for the following offices: President/BA; Vice President/BA; Night Business Agent; Dispatcher (4); Sgt-at-Arms; Labor Relations Committeeperson; Grievance Committee (20); Executive Board (11); Board of Trustees (3); Promotions Committee (6); and Caucus/Convention Delegates (10).

NOVEMBER ELECTION INFORMATION – Official ballots shall be mailed out no later than Friday, November 8th. Ballots must be received at Local 63's P.O. Box or in the ballot box located in the Local 63 Business Office lobby by 10:00 a.m. on Monday, December 2nd in order to be counted. Ballots shall be counted by the Local 63 Balloting Committee in accordance with the Local 63 election policy, rules and procedures with results posted by 5:00 p.m. on Mon., December 2nd.

PAID HOLIDAY – MONDAY, NOVEMBER 11, 2019 – VETERANS' DAY – It is a normal work day and all work performed on that day shall be paid at the overtime rate. This is an automatic holiday for those members who worked at least 1300 hours (1200 if age 60 or over) in 2018. For those members who did not, they must work at least two (2) of the four (4) days exclusive of the holiday date, Tuesday, Wednesday, Thursday, or Friday, November 12th, 13th, 14th or 15th. Please note that only those members who worked at least 800 hours (700 if age 60 or over) in 2018 are eligible to receive or file holiday claims, members who were on disability during 2018 should be aware of their actual hours worked during that year to know how their 2019 holidays are affected. Members who worked at least 800 hours but less than 1300 in 2018 (700 but less than 1200 for age 60 and over) and who may be off on disability during the holiday week must request that the Business Office staff file a claim on their behalf with the current medical documentation which excuses them for the holiday week (Monday-Friday). Members who are on vacation during a holiday week must notify the Records Clerk.

<u>PAID HOLIDAY – THURSDAY, NOVEMBER 28, 2019 – THANKSGIVING DAY</u> – Is a no work holiday; members must be available to work two (2) of the four (4) days exclusive of the holiday, Monday, Tuesday, Wednesday or Friday, November 25th, 26th, 27th or 29th Members who are on disability during that week must submit written medical documentation to the Business Office staff covering them for the holiday week and request that they file a claim on their behalf. Members who are on vacation during the holiday week (Monday-Friday) must notify the Records Clerk prior to the end of that week. Note, only members who worked at least 800 hours (700 if age 60 over) in 2018 are eligible to receive or file for holiday claims for 2019.

<u>22nd ANNUAL FEED THE COMMUNITY DAY</u> – As you know, Thanksgiving is a time that we choose to celebrate our blessings with the less fortunate. Each year we feed over 1,500 families for Thanksgiving. This year our event will take place on Tuesday, November 26th, from 7:00 a.m. - 5:00 p.m. at the Memorial Hall located at: 231 West "C" Street in Wilmington. Please come out and volunteer for a few hours on Monday, November 25th from 8:00 a.m. to 12:00 p.m. to help prepare for the event the following morning. The Committee would love the help and support of our Local 63 members both days.

WORKING & DISPATCH RULES REMINDERS – All Yard Planners, Rail Planners, and Vessel Planners work in exempt categories which are not subject to the 50/50 Rule. Therefore, members cannot seek extra work through their Employer outside of their category at the dock they are Steady. Steadies who wish to perform work outside their primary category must do so through the Dispatch Hall reference: 50/50 Rule, Working & Dispatch Rule GD-16B Jobs Originate in the Hall & S-15 – Clerk Posting.

<u>50/50 RULE REMINDER</u> – All key jobs only, shall be 50/50 (50% Hall/ 50% Steady) 7 days a week in the following manner: Supercargo, Yard/Vessel (combined), Rail and Tower. Tower steadies may not be shifted to work outside the tower. If you have any questions about any 50/50 issues, please call the Business Agent or the Business Office.

<u>BENEFICIARY DESIGNATION</u> — As a reminder, it is a good idea to update your Life Insurance beneficiary. Benefit Plans will *not* provide the name of your beneficiary to you if you call them, they will advise you to complete a new form and submit it to them. So, if you don't remember who you listed, or need to make any changes, you can pick up the form in the business office or print the form from our website under Resources/ILWU-PMA Benefit Plans/Forms/General Forms/Beneficiary Designation Form. Once completed, mail directly to Benefit Plans to address listed on the form — Local 63 does not keep these on file.
