NEW BUSINESS

1. LA-LB CLEANING PROTOCOLS & 6:00 PM SECOND SHIFT START TIMES

The Committee noted the most-recent CLRC COVID-19 cleaning protocol extension expired on Sunday February 28, 2021.

Following extensive discussion, the JPLRCs agreed to the following:

1. Absent joint agreement from the CLRC to extend CLRC Meeting No. 12-20, the Ports of Los Angeles and Long Beach will return to a 6:00 p.m. Second Shift start time as outlined in Section 2.41 of the PCL&CA, and Section 2.2 of the PCWB&FA commencing Saturday, March 6, 2021.
2. Prior to the start of the first shift the employers shall clean/disinfect all equipment, including all high-touch areas and surfaces that will be utilized that day e.g., shuttle buses, offices, check-in areas, break rooms, rest rooms, etc.
3. All employers in the Ports of Los Angeles and Long Beach will make every effort to purchase and utilize electrostatic sprayers (or their equivalent) to clean pickup trucks, UTRs, all high-touch areas and surfaces e.g., shuttle buses, offices, check-in areas, break rooms, rest rooms, etc. and any other equipment that will not be damaged by the sprayers, commencing Saturday March 6, 2021. The employers shall utilize these sprayers to clean between shifts on the equipment and work areas listed here in Item 3.

4. Operators in hammerhead cranes, transtainers, top handlers, and side picks will be provided sanitizing wipes to clean their own equipment a) between the first and second shifts and b) between the second and third shifts equipment. A mechanic will be made available to assist in the cleaning of this equipment if requested.
 5. The employers will provide longshoremen, clerks, and foremen with cleaning supplies and PPE for the items listed in Items #2-4 as per CDC guidelines. A mechanic will be available to assist in cleaning if requested.
 6. The JPLRCs may discuss other methods of cleaning/disinfecting as they become available. Marine terminals may use a long-lasting disinfectant, (SurfaceWise2 or similar products), upon approval from the appropriate regulatory authority, and thereafter the disinfecting described in Items #2- 4 will occur periodically, as recommended by the manufacturer and agreed to by the JPLRCs.
 7. ILWU sweepers will clean/disinfect per CDC guidelines within their usual practices.
 8. The Committees will convene and revisit these protocols if the appropriate regulatory authorities modify their cleaning guidelines.

The Committees agreed that Local 13 did not waive its contractual right for mechanics to clean equipment but do recognize the logistical problems of CDC cleaning recommendations during the COVID-19 pandemic. The Committees shall continue to meet weekly to review the protocols.
